


O R D E R

WHEREAS, on the 29th day of January, 1979, at the hour of 11:00 o'clock A.M., at the Board of Supervisors Meeting Room, Court House, Flagstaff, Coconino County, Arizona, pursuant to Arizona Revised Statutes, 9-1006, the Board of Supervisors heard the Petition of the residents of properties within patented mining claims known as MESA VERDE # 6, MESA VERDE # 5; GLORY HOLE # 3, all in Township 11 North, Range 15 East, Sections 17 and 20, as recorded in the records of the Coconino County Assessor's Office, Flagstaff, Arizona, for annexation of said section into the Forest Lakes Volunteer Fire District; and
